This Memorandum of Understanding (“MOU”) is entered into by and between the MiraCosta Community College District (hereinafter referred to as "District") and the MiraCosta College Faculty Assembly (hereinafter referred to as "Assembly") (hereinafter collectively referred to as the “Parties”), and is expressly made pursuant to the Educational Employment Relations Act and the current Collective Bargaining Agreement (“CBA”).


The District and the Assembly have met and conferred regarding the Director of the Child Development Center position resulting in the separation of the duties of the Child Development Director – assigning faculty coordinator duties to faculty and administrative duties to a non-faculty position; and agree as follows:

1. The title “Director, Child Development Center” in Appendix 5.1 of the CBA will be updated to read “Coordinator, Child Development Center.”
2. The amount of reassigned time in Appendix 5.1 related to the Child Development Center shall remain unchanged for the remaining term of the existing CBA. The district shall offer the reassigned time associated with the coordinator position to full-time faculty in the Child Development Center. If no full-time faculty member accepts the coordinator position, the district may offer the reassigned time to an associate faculty member.

This agreement will become effective upon approval from the Board of Trustees and shall expire June 30, 2025.
