POLICY HIGHLIGHTS

- California Residency
 - Principal place of residence
 - “One true, permanent home”
 - Tax filings, property ownership
 - Driver’s license
 - PO Box insufficient
- 200 mile range to primary worksite
- All Employees
 - Full and part time District Personnel
 - Faculty, classified professionals, administrators



POLICY HIGHLIGHTS



- Exceptions case-by-case basis upon approval of VP HR
 - Not to exceed twelve consecutive months
 - Decision resides solely with the District
 - No appeal procedure
- Violations
 - May be subject to termination
 - Dishonesty Policy
- Date of Implementation: *Month/Date, 2023*
